I thanked Presbytery of New Hope on behalf of the Presbytery of Boston. The Rev. Katherine Cole is now a member of the Presbytery of Boston.

Report from the Waltham Administrative Commission for the March 23, 2018, Meeting of the Boston Presbytery

Members: Ruthie Seiders (Chair), Su Young Kim, Carol Patey, Betty Rots, and TJ DeMarco (ex officio)

The Waltham Administrative Commission first convened in late December 2017 and has met several times since then, including four times with the First Presbyterian Church of Waltham's Session. As part of our deliberations, we have considered views of the Session. In addition, we spoke with various groups in the Presbytery to hear suggestions on use of the property. We feel we are now able to make recommendations to the Presbytery.

We were asked: To discern whether it is wise to recommend that Presbytery dissolve the First Presbyterian Church of Waltham and to recommend to the Presbytery, if it deems appropriate, that the congregation be dissolved.

We considered the report from the response team and discussed with the Session their views on dissolving. After consideration, the Session determined they wished to merge with the Hartford Street Presbyterian Church in Natick. Of the twelve members, nine would like their membership transferred to the Hartford Street Church, one would like his membership transferred to the Presbyterian Church in Needham, and two would like their membership to be held by the Presbytery Stated Clerk for later transfer. *The commission recommends the merger with the Natick congregation pending their Session approval*. (Session approval had not yet taken place as of this report's preparation.)

We were asked: To determine the ongoing expenses of the building such as insurance, utilities, debt services, etc., and to review all current rental relationships and the income from rentals.

We have determined the ongoing expenses and determined that income from the tenants covers the regular expenses. Ongoing janitorial services and building management services have been obtained. We will be discussing the status with all tenants. Andy Parmelee, Presbytery Treasurer, has agreed to pay expenses and deposit rental checks using a fund he will set up for this purpose after the congregation is dissolved.

We were asked: To review any assets that the congregation owns.

An investment account with about \$28,700 has been liquidated. These funds will be transferred to the Presbytery Treasurer's control. In addition, the unused balance of a Presbytery grant—\$2,690—will be returned to the Presbytery. The Commission recommends to Presbytery that all or a significant portion of the cash assets of the First Presbyterian Church of Waltham, separate from the proceeds of the sale, be given to the Hartford Street Presbyterian Church upon the sale of the property and final payment of all bills.

The Session specifically asked that the following be included in this report:

The church has an investment account of approximately \$28,700.00 which has been liquidated to the church's savings account. The Session respectfully requests that this

\$28,700.00 be gifted to the Hartford Street Presbyterian Church upon the merger of the nine members from First Presbyterian to Hartford Street.

We were asked: To discern and recommend whether the building should be sold.

We sought recommendations from the Presbytery Council, the Committee on Ministry, the Committee on Congregation Support and Development, and the Presbytery Trustees on potential uses for the building. Although some ideas were raised for Presbytery-related uses of the Waltham church, the groups were concerned about ongoing costs of maintenance and utilities and costs of renovations to make such uses feasible. The commission recommends to Presbytery that, barring any feasible suggestions of which the commission is now unaware, that the First Presbyterian Church of Waltham building be sold.

In this regard, the Waltham Session has specifically requested that the following be included in the commission's report:

The Session of the First Presbyterian Church of Waltham requests that upon the sale of the 34 Alder Street property that the proceeds be used to further the mission programs of the Presbytery of Boston, as stated in its mission statement: "strengthening and growing congregations of Presbytery by providing guidance and resources for their ministries and by encouraging partnerships." The funds should not be allocated for administrative or operational budgets.

We are aware of one party who contacted the Presbytery office and is interested in discussing purchasing it. In addition, one of the tenants has expressed interest in buying the building in the past.

We were asked: To plan with the congregation a final worship service to which members of the Presbytery of Boston and its congregations will be invited.

The last congregational worship was held on March 4, 2018. The final worship service with the Presbytery will be April 8, 2018, at 3:30 pm. Plans for the service are being finalized.

1.2 Communication Coordinator

- 1.2.1 Our conclusion has been that staffing and expenses are basically at their minimum required level to support the presbytery's (and its churches') mission and that we can only expect the presbytery to be financially healthy in the future if that expenditure level can be supported through member church giving in both per capita and undesignated mission giving. However, we believe that one can only expect that to work if the member congregations recognize the value of the presbytery's contribution to their mission.
- 1.2.2 The question is simply this: is any congregation's mission ministry better off with paying per capita and the support of the presbytery's connectional mission support?

OR

without the presbytery and applying the funds spent on presbytery support, both per capita and mission giving, directly to its own mission?

The Presbytery must provide specific and compelling answers to those questions

- 1.2.3 In order to enhance the presbytery's support for the congregations' ministry of mission and make the value of that connectional support visible, we see the need for two key new pieces to the Presbytery of Boston's life.
 - 1.2.3.a a skilled Communication Coordinator.
 - 1.2.3.b This would be a considerable upgrade to what currently appears in the budget as C.11 and C.12: Administrative Assistant (\$25,518).
 - 1.2.3.c Improving congregational knowledge of Presbytery's Mission

- 1.2.3.d Perhaps even being a resource to congregations in their own efforts at effective communication
- 1.2.3 That upgrade needs to come in three areas: required skills, hours, and compensation. Our sense is that we are looking at an increase of \$25,000 to \$30,000 (probably on the high end) per year and that we should not skimp on this position, because it is one of the two most crucial elements in bringing the presbytery back to financial health.
- 1.2.4 Council should investigate possibilities of making this a shared position between Presbytery of Northern New England and Presbytery of Boston.
- 1.2.5 The second crucial element will be a Shared Mission Goal, considered later in the proposal.

March 2018 Resource Presbyter Report to Presbytery



March Presbytery Worship Offering

The Council voted for the March Assembly worship offering to be directed to the Presbytery of Tropical Florida as they work to respond to the gun violence at Marjory Stoneman Douglas High School in Parkland, Florida. I reached out to my colleague to hear a little bit about how the Presbytery is responding.

From Daris Bultena, General Presbyter, Presbytery of Tropical Florida

There are some really interesting stories to tell. We held a vigil two days after the shooting. It was also the evening we invited pastors to come together and talk about what it means to do ministry in the aftermath of such events. We expected that the vigil would be attended by pastors and elders of our congregations. And it was, but it was also attended by high school students and their parents. I was doing anointing that evening for any who wanted it. That was taking place at the front of the sanctuary where there was also a table for lighting candles. As I anointed people I said, "The light shines in the darkness and the darkness cannot overcome it." (We spoke that line 17 times at the beginning of the service as we lit 17 candles for the fallen victims.) I followed that line at the anointing with, "And the one who is the Light of the World is in you." And a teenage girl looked back at me and said, "In my friends, too." I responded with the word, "Absolutely." I carry her image with me.

We are finding many stories of people in our congregations who know someone who teaches in that school, who know someone who was there that day, and who knows a neighbor who lost someone. The stories of connections continue to bring home the reality of the smallness of our community even though Broward County has millions of people in it.

Our churches are doing a letter writing campaign...they are inviting children in their church to write letters of support and encouragement with words, pictures, etc. We are in contact with school counselors and will be delivering those to the school. We are also going to try and learn how we can provide a bit more longer term support and counseling services. We know that many of the services being provided now are short term. We are using the model that Presbyterian Disaster Assistance uses of strategizing how we can be involved for the long-term recovery.

I wish I could say that we are going to do such-and-such a program, but we don't have that in order yet. We are still figuring this out along the way. I'm learning from others and together we are floating ideas. Hopefully soon we can point to specifies of how we want to be involved for that longer term.

On behalf of the Presbytery, I thank you for your kind efforts of considering support for our work that really is just beginning. These days have served to remind us again how truly connectional we are as PCUSA.

Boston Food Justice YAV invites God to the table

Intentional living in community makes a house a home away from home

ork is an important part of vocation, but an equally important place to live out my calling is in my new home. My current home as a Young Adult Volunteer (YAV) is an intentional Christian community in Boston, where my fellow YAVs and I seek to build faithful relationships with each other, with our neighbors and with God. My year of service is teaching me that "being in mission" is a way of living that starts in the place where I eat, rest, reflect and pray with those closest to me.

My discernment toward becoming a YAV did not start with God calling me to leave everything and serve in a faraway place. Instead, I heard God asking to be invited into my life and calling me to be intentional about how I live. Becoming a YAV did take me away from where I grew up, but has also given me the opportunity to organize my life around service and ministry. Just as I look to God for guidance when I am at work volunteering, I look to God for guidance when I am at our YAV house, discerning how to spend time and money while building relationships with members of my community.

Hardly anything we do at the YAV house is more significant than nourishing and sustaining ourselves by eating. The YAV site in Boston is focused on food justice, the movement to promote equity, sustainability and nutrition in how we produce, distribute and consume our food. My fellow YAVs and I all work for organizations that address root causes of hunger, but we also live out food justice by carefully examining our own eating habits. Our community has been especially built around gathering at a

table together and better understanding our relationship to our food system. In my home as a Boston Food Justice YAV, I hear God calling me to make decisions about food that benefit God's people and God's creation.

My discernment toward becoming a YAV did not start with God calling me to leave everything and serve in a faraway place. Instead, I heard God asking to be invited into my life and calling me to be intentional about how I live.

This year I am finding that my calling is not only about what I do, but also about who I am, what I live for and what matters to me. God 30ks to be invited

into the place closest to my heart, into the relationships and practices that make me who I am. That place, my new home in community with other YAVs, is where I discern how God is calling me to live and intentionally use my gifts. Through consciousness about food justice and Christian reflection with my housemates, I am building an intentional Christian home, learning how to be a compassionate and hospitable member of my community, and answering God at my door.

Journey of Faith Andrew (Drew) Hanson

My journey of faith is continuous. I am thankful for the opportunity to reflect on it, as looking back shows me the growth that God has created in me. While I never had a single, significant conversion experience, my faith journey has been, in a way, a continuous conversion and development as I have experienced God in different ways. I am continually growing in my knowledge of God, Scripture, worship, discipleship, and faith. Today, that journey continues as I grow in my knowledge of how to be a pastor as I live out my call to ministry.

I grew up in the church and have enjoyed worship and reading Scripture for as long as I can remember. My family attended PCUSA churches because my maternal grandfather was a Presbyterian pastor. Though he died when I was two, he still influenced where we worshiped. I also attended a Lutheran church with my paternal grandparents. No matter the type of worship service, I desired to stay with the adults rather than leave for Sunday School. I enjoyed singing hymns, listening to the sermon, and partaking in communion. I was also one of those kids who desired to be an adult more than a kid. Once, when I was in Elementary School, I experienced what I can only describe as God's presence through communion. Though I could not explain it at the time, I felt a warm embrace when I closed my eyes and prayed after taking communion. It was a transcendental moment that I will never forget.

Throughout my childhood, many relationships helped me navigate and move forward with my faith journey. My relationship with my parents helped me experience God's love, and they taught me how to pray regularly. My maternal grandmother, whose faith is more fundamentalist, walked me through the "Sinner's Prayer" and emphasized reading and memorizing Scripture. My paternal grandparents are also both devout Christians, as my grandmother's father was an itinerate pastor to Norwegian farmers in northern Minnesota, and several of her brothers became pastors. They would take me to church functions at their small Lutheran congregation, and also instilled in me the importance of prayer. And even though I never truly met him, my relationship with my deceased maternal grandfather was important in my faith journey. I was told by many that I was like him, from facial features to the ways our minds work. This told me, subconsciously, that because he was a pastor, I was like a pastor. This helped me develop my faith and played a role in my call to ministry.

In high school, I joined a youth group that developed my faith from belief to discipleship. It was the point in my life when I became aware of the role my faith played in how I lived and how I treated people. Through camps and mission trips, along with regular youth group and Bible studies, I grew into a deeper faith. I also learned the importance of a faith community while in high school, as I found myself being at church several times a week to support, and be supported by, my youth group friends and mentors. I am thankful for my youth pastors, who saw in me the gifts of a pastor. Their testimony in my life played a role in my call to ministry.

In college, I set aside faith when it was not convenient. I went to a very secular school. I chose Occidental College to follow my passion of studying marine biology, play rugby, and enjoy the "college experience." I would attend church occasionally, but in general, the discipleship I developed in high school was put on hold. I still attended annual college camps with my youth

group friends, and my faith was enhanced there. One summer, between my junior and senior years of college, I experienced God in a similar way to when I took communion all those years ago. I heard what I believe the still, small voice of God calling me into ministry. It had been in the back of my mind, but I knew at that point that I was all in. I was fully committed to my life of faith and to my call to ministry.

Ministry and seminary played major roles in my faith journey since beginning on this path. In some ways, affirmations of my call to ministry have also been a part of the journey. While at Fuller, God continuously affirmed my sense of calling. I had never enjoyed school as much as I did in seminary, and I could not get enough of my studies, class time, and friendships. I was involved in beginning Fuller's Faith and Science student group, and that helped me tremendously in combining my passion for marine biology and my call to ministry. It helped me develop an awareness of how I could bring ideas of ecological conservation to Christian ideas of creation care, and how I could (hopefully) help my fellow Christians be less afraid of science. While in seminary, I was hired as a High School Ministry Intern at La Canada Presbyterian Church, where I had my first real experience in ministry. After the yearlong internship ended, I began working as the part-time Director of Youth Ministry at Beverly Hills Presbyterian Church. After graduating seminary, I was hired full-time at BHPC as Family Ministries Director. In this role, I have been able to preach more frequently and lead various groups, from youth group to Sunday School volunteer teachers to adult Bible studies. These experiences affirmed, and continue to affirm, my call to ministry. I fell in love with teaching, preaching, and counseling. I found my faith strengthened by these. Praying, preparing lessons and sermons, serving on committees and alongside congregants in service projects, and even dealing with the mundane tasks of ministry are all a part of my faith journey.

My faith journey has moved from a largely individualistic view of Christianity to a more holistic view. My time in seminary exposed me to many types of Christianity, and introduced me to much larger views of justice, missions, and discipleship. I began viewing faith and sin as larger than just what I believe and what I have done wrong. Faith is both individual and communal, as faith in incomplete without corporate worship. Sin is both individual and communal, as there are countless systemic sins in which we are complicit. I learned from this development that my faith continues to grow and stretch, that God is bigger than I'll ever comprehend, and that it is important to read authors and interact with people who are different so that I can continue to grow in my faith.

Statement of Faith Andrew (Drew) Hanson

I believe that God is triune: one God in three persons (Father, Son, and Holy Spirit). The three are co-eternal, and of the same essence and power. I believe God is the Creator of all and that humanity was created in God's image. But humanity rebelled, which sent us into the spiral of sin and death. Only God could redeem us, and he did so through Jesus Christ, who is fully human and fully divine. Through Jesus' atoning death and resurrection, we have the opportunity to know God and to be saved from sin and death. Through Jesus, we have a renewed covenant with the Living God. Today, we have the gift of the indwelling Holy Spirit, who continues to guide, speak, convict and comfort us.

I believe that we know this story of creation, fall, and redemption through God's revelation in the Holy Scriptures. I believe that, like Jesus, the Bible is both divine and human. It is divine in that it is God-breathed and it is the most faithful tool to describe who God is, what God's will is, and how humanity relates to God. It is human in that it is a compilation of different texts, written by different people in different contexts. It should be read both as a document within the original context and as an authoritative, living document that speaks to us and convicts us today through the inspiration of the Holy Spirit.

I believe that, as the Church, the body of Christ, we are called to live out God's will by God's grace through faith. We did not earn the ability or the privilege to live out God's will, but only through God's grace, Jesus' sacrifice, and through the Holy Spirit's guidance. I believe that our relationship with God is both individual and communal. We are invited to pray, read Scripture, confess sin and repent, seek justice, love our neighbors, and love and worship God as individuals and corporately. Corporate worship includes the two sacraments, baptism and communion, which are visible signs of God's invisible grace. Baptism is the visible sign of God grafting us into the covenant community through grace, and of baptism by water as a sign of God baptizing us with the Holy Spirit and fire. In communion, Jesus is spiritually, but not bodily, present in the bread and cup. The elements are the visible signs of Christ's sacrifice providing nourishment and communion with God and neighbor through grace.

The efficacy of the Gospel is eternal. Christ's resurrection is the first fruit of our own. At Christ's Second Coming, when Jesus judges the living and the dead, our bodies will be raised to enjoy and worship God in the eternal Kingdom. The resurrection of the body testifies that eternal life will be an embodied life, thanks to Christ's resurrection. It is God alone, in grace and sovereignty, who is judge.

While eternal, the good news of the Gospel must also be tangible, here and now. As faithful individuals and communities, we are called to do justice, love kindness, and walk humbly with God. This means that a part of our faith is being called to work for justice for the marginalized, to be a voice for the voiceless in loving kindness and humility. Seeking forgiveness of sin and repenting are important parts of walking humbly with God. As faith is both individual and communal, sin can be as well. While individuals sin, there are also systemic sins that plague our world and demonstrate that God's work of redemption is not complete in all creation. The church is called to repent of both individual and corporate sins. Repentance is the response to God's forgiveness, as the one asking forgiveness is called to simultaneously turn away from sin and toward God. Likewise, God's redeeming grace is not just meant for individuals, but also for humanity and for the larger creation.

Alongside my academic studies I have followed a spiritual path that is precious to me: In 1983 a Jesuit priest offered a workshop on "Zen-Meditation for Christians" that touched me deeply. I have been drawn to silent, contemplative and centering prayer ever since. After going there on yearly retreats for several years, I spent a year in a Jesuit Retreat House in Germany in 1992, assisting with ten-day retreats in contemplative prayer and having space for several hours of silent meditation every day. I have gone on spiritual retreats in silent contemplative prayer since 35 years. That is where I foster my connection with the deepest mystery of all we call God.
