BIOS:

Jill Auger (RE-2, Clarendon Hills): Committee on Ministry, Chair

Jill Auger, a ruling elder from Clarendon Hill Presbyterian Church, is serving on the Committee on Ministry for the second time. She is also currently serving a term on her church's session, and she has previously served on a presbytery response team and on a PNC at Clarendon Hill. She is a life-long Presbyterian, with roots back to Scotland, and her parents met at Princeton Seminary (where they knew Tom and Pat Kepler). Her father, Tom Fisher, is an honorably retired Presbyterian pastor. She has degrees from the University of Chicago Divinity School and Smith College and has worked in publishing, editing, and libraries. She and her husband, Pierre, have two grown children, one in the Boston area and the other in New York City.

Virginia Coakley (TE-1, Validated Ministry): Committee on Ministry, 2021

Rev. Virginia "Ginny" Coakley is an Ordained Teaching Elder in the Presbyterian Church (PCUSA) and a member at large of the Presbytery of Boston. She was ordained by the POB in 2015 in Worcester, MA where she served as an Associate Chaplain/Director of Protestant and ALANA Ministries at College of the Holy Cross in Worcester, MA, for nine years. She left campus ministry to serve as a Transitional Pastor at the First United Presbyterian Church in Cambridge, MA. After completing her year-long contract, she relocated to rural upstate New York where she served as an Installed Solo Pastor for the First Presbyterian Church in Dryden. She is very glad to be back in Massachusetts, she is currently working in an area not for profit, supporting women and men living with AIDS or who are HIV+ to ensure they are living as successful lives as possible.

Virginia has been involved in ministry in various capacities for many years. In addition to serving as Pastor and Campus Minister, her service includes Coordinator of Missions and Evangelism, Coordinator of Prison Ministry, Youth Minister and Pastoral Counselor at parishes in Dorchester, Roxbury and Cambridge, MA. Her passions are preaching, teaching, and missions. She has participated in service and missions' trips to El Salvador, Brazil, and St. Kitts, West Indies. She is also interested in cultivating good leaders in the church and beyond and participated in an 8-day Global Transformational Leadership Summit in Bloemfontein, South Africa.

Virginia is a graduate of Boston University School of Theology class of 2006; she holds a Master of Divinity Degree. Her undergraduate degree is from Lesley University; she holds a Bachelor of Science in Human Service, Specializing in Counseling Psychology. She currently resides in Brighton, MA.

Katie Cole (TE-1, Fourth): Nominating Committee, 2023

Katie Cole is the Associate Pastor at Fourth Presbyterian Church. She was ordained in 2018, though she has served at Fourth in a full-time capacity since 2013. She graduated from Boston University School of Theology and the School of Social Work in 2012, and has a background in youth ministry, trauma work, and community organizing. Her favorite Presbyterian is Jenny Geddes (1600-1660, Edinburgh), who teaches us that Presbyterian women are mighty and to be feared.

Thatcher Freeborn (RE-2, Fourth): Trustees, 2023

Thatcher is currently a Ruling Elder and former Deacon at Fourth Presbyterian Church. He serves as Treasurer of The Vinton Street Hope Initiative, Inc., Treasurer of the Massachusetts Council of

Churches, and former Board member of the Boston Food Justice Young Adult Volunteer Program within the Presbytery. He is a Past Moderator of the Presbytery of Boston, Past Chair of the Stewardship and Budget Committee, a member of the Fort Square Presbyterian Church and Presbyterian Church in Needham Administrative Commissions and past Trustee for the Synod of the Northeast of the Presbyterian Church USA. Professionally, Thatcher serves as Senior Vice President, Team Leader, Nonprofit Lending Group, for Boston Private Bank. He is married to Erin Freeborn, M.Div. JD, Executive Director of Communities for Restorative Justice. They reside in Melrose with their three daughters.

Drew Hanson (TE-1, Quincy): Committee on Preparation for Ministry, Vice-Chair, 2021

Rev. Drew Hanson was born and raised in California and lived there until receiving his first call at First Presbyterian Church, Quincy in 2018. He graduated from Occidental College with a B.A. in Biology, emphasis in Marine Biology, and from Fuller Theological Seminary with an M.Div. Drew met his wife, Cassie, in college at Occidental and they now live in Braintree with their three-legged dog, Ruth. Drew's hobbies include hiking, kayaking, eating, watching TV while eating, and cooking food for said eating. Since the pandemic, his hobbies also include creating a sourdough starter named Mick Jagger (think: Start Me Up), building a raised garden bed to grow food to sustain all that eating, creating a batch of homebrew beer, watching even more TV while eating, and figuring out how to enjoy seeing loved ones on Zoom after too many work Zoom meetings.

Kayla McKinsey (TE-1, Validated Ministry): Nominating Committee, 2023

Kayla, who grew up attending Good Shepherd Presbyterian in Easton, MA, is serving in her first call as Associate Pastor at The Dover Church in Dover, MA. At TDC, Kayla leads worship and spearheads the youth group, Christian Ed, and confirmation programs. She developed her passion for learning with and from young people through her connection to Camp Wilmot, a PCUSA overnight camp in the Lake Sunapee region of New Hampshire. As a camper and now a director, Camp Wilmot has been a place where Kayla has witnessed the transformative power of belonging, play, and immersion in God's creation. Kayla enjoys running, reading, gardening, cooking, hiking, and spending time with her family, friends, and her fiancé Walter.

Jean Olson (RE-2, Sudbury): Committee on Preparation for Ministry, 2023

Jean grew up in Walpole, MA, and has lived in Rochester, NY, Baltimore, and San Francisco. She returned to be near family when she retired and now lives in Concord, MA. She was a Professor of Pathology and was on the faculty at The Johns Hopkins University and University of California San Francisco. Jean joined the PCUSA in the mid-1980s. She was brought up in the UCC, and was ordained as a PCUSA ruling elder in 1992. She served several Presbytery committees of the Presbytery of San Francisco. Her service included the Committee for Preparation for Ministry, 6 years, chair 1 year, Committee on Ministry, 3 years, and a Presbytery Engagement Team. The Engagement Team aided a congregation in its discernment over whether to leave the Presbytery. They chose to remain. Jean was a reader for ordination exams over 5 years. She was elected as West Regional Convener to the Presbyteries Cooperative Committee on Examination for Candidates and has served that committee for four years. She is a member of the Presbyterian Church in Sudbury.

Andrew Parmelee (TE-2, Honorably Retired): Treasurer, 2023

Andy Parmelee is the current treasurer of the Presbytery. A member of the Presbytery of Boston since 1982 he was first elected treasurer in 2011. Over the years he has served the Presbytery as a stated supply pastor, administrative commissions' chairperson, chairperson of several fund-raising campaigns within the Presbytery, several terms as a Trustee prior to becoming treasurer and COM chairperson for

two terms. He served the Synod of the Northeast for two terms as its Budget and Finance chairperson and has been both a Synod and GA commissioner for the Presbytery. Semi-retired he lives in Hingham, and like many of us today he works from home, worships, shares in fellowship activities and visits with his family from afar on ZOOM! His favorite ZOOM activity these days is relearning and studying French with his son and a grandson in California occasionally supported by a tutor in Paris.

Aaron Shepherd (TE-1, Validated Ministry): Committee on Ministry, 2023

Rev. Dr. Aaron Pratt Shepherd is an Assistant Teaching Professor of Philosophy at University of Massachusetts Lowell and an ordained Minister of Word and Sacrament in the Presbyterian Church (U.S.A.). He holds a PhD in Philosophy from Emory University, as well as Bachelor and Master's Degrees from universities in his home state of Oregon, and studied at both the Candler School of Theology and Columbia Theological Seminary in the Atlanta area. Ordained in 2019 in the Presbytery of the Cascades, Rev. Dr. Shepherd currently serves as Pastor of Union Congregational Church in East Walpole, MA, and has Dual Standing with the Presbytery of Boston and the Metro Boston Association of the Southern New England Conference of the United Church of Christ. His first book, *Challenging the New Atheism: Pragmatic Confrontations in the Philosophy of Religion*, was published this fall with Taylor and Francis Publishers as part of the Routledge Studies in American Philosophy series. He and his wife Whitney live in East Walpole with their three sons, Brady, Jett, and Calvin.

Paul Shifflet (RE-2): Trustees Investment Sub-committee, 2023

Paul is from Charlotte, NC. He moved to Boston during the summer of 2017 after obtaining his MBA from the Wharton School of the University of Pennsylvania in Philadelphia. He is currently a member of Arch Street Presbyterian Church in Philadelphia and is actively seeking a church home in Boston. Paul was raised Presbyterian at First Presbyterian Church in Charlotte and is an ordained Ruling Elder of the Presbyterian Church (USA). While at Arch Street Paul served on Session and chaired the Finance Committee. In addition to leading the annual budgeting process, the Finance Committee was responsible for stewarding the church's approximately \$3 million endowment. Paul drafted the church's first Investment Policy Statement and, as a member of the Committee, advised the endowment's external manager on asset allocation decisions. Paul is an Equity Research Analyst at Eaton Vance Management and is a CFA charter holder. He is responsible for the US Large Cap Value fund's investments in regional banks. He regularly collaborates with members of the firm's equity and credit analysts, and portfolio managers. Paul graduated from Haverford College in 2011 with a BA in Economics and an MBA from Wharton in 2017.

Ivy Jones Turner (Member-2, Roxbury): Council Member-at-Large, 2023

Ivy Jones Turner is an ordained Deacon at Roxbury Presbyterian Church where she has been a member since 1990 shortly after moving to Boston. Currently at RPC, Ivy is a member of the Social Justice Mission Team -- which works closely with GBIO, and the Ensemble Choir, and previously was Sunday School Co-Superintendent. Since arriving in Boston, Ivy has served on the Boston Presbytery Nominating Committee as well as the Boston Presbytery Budget and Finance Task Force, and is currently a member of Council and chair of the Budget Task Force which has been charged with developing a plan for a balanced budget for the Presbytery of Boston.

Originally from Charleston, South Carolina, Ivy was active as a youth member of Zion United (later Hebron-Zion) Presbyterian Church, where her family is still actively involved in the Charleston-Atlantic Presbytery. Ivy is a graduate of Johnson C. Smith University in Charlotte, NC, a Presbyterian college, and the John F. Kennedy School of Government at Harvard University. Ivy works at Education Development Center in Waltham, providing training and technical assistance to state and local agencies

and local community-based organizations as leading substance abuse, violence, and suicide prevention programs. In her spare time, Ivy enjoys quilting, reading and cooking. Ivy is married to Bradley Turner, an Elder at RPC, where they live in Dorchester.

Beth Wieman (TE-2, Hyde Park): Committee on Ministry, 2023

Beth has been a member of Boston Presbytery since 1987. She is currently the Pastor of Hyde Park Presbyterian Church. Before Hyde Park she served as the Minister of Christian Education at Church of the Covenant, and before that she was the Associate Pastor of Grace Church UCC in Framingham. She has served as Vice Moderator and Moderator of the Presbytery, chaired Budget, Nominating, Committee on Church Support and Development, and the Committee on Education for Ministry. Beth served as a Presbytery of Boston General Assembly commissioner to the 2006 Assembly in Birmingham. She also chaired the search committee that called George Magnuson to be the General Presbyter of Boston Presbytery. She has completed one term on COM, this would be her second. Beth lives in Boston with her husband Mark Leach.

Jane Wilson (TE-2, Validated Ministry): Moderator, 2021

A cradle Presbyterian, Rev. Jane Wilson grew up in the church in her small Northern New York village. After graduate school, Jane began a career with the Federal Government in the Washington, DC area. She joined a Presbyterian Church in the Foggy Bottom area where she became active, serving as a Deacon. While involved with a church-sponsored tutoring program, Jane received a call to ministry. She attended Union Presbyterian Seminary in Richmond, VA earning an MDiv and a MACE. Since ordination in 1998, Jane has served churches in Ohio, Arizona, and North Carolina. She now serves a UCC church in Milford, MA.

RELATIONSHIPS:

The Administrative Staff Person (ASP) will relate to:

- The Stated Clerk, who will supervise and provide materials and information as necessary (including Presbytery Meeting packet materials and information for the directory).
- Committee members or members of Presbytery as needed for information
- The Personnel Committee for regular review

RESPONSIBILITIES:

- Attend all Presbytery meetings to manage tech
- Manage Newsletter: receive information, edit and prepare online newsletter, send once per week
- Monitor office@presbyteryofboston and presbyter@presbyteryofboston.org email and forward to appropriate people
- Website Management:
 - o updating webpages with appropriate resources, dates, photos, and attachments.
 - o creating new webpages as needed.
 - o responding to requests for new user logins or lost login information.
 - o Prepare and distribute stated meeting packets
- Keep Presbytery Directory up to date, including:
 - o Accurate church contact information, including address, email address, phone number, and contact for Clerks of Session
 - o Accurate Minister information, including HR status
 - o Proactively reaching out to COM, Deacons and Stated Clerk and monitoring Presbytery minutes for changes
 - o Moving the directory into a more useable format (online or database) by March 2021, with format to be approved by Stated Clerk
- Manage Presbytery Facebook Page
 - o Share weekly newsletter
 - o Create and manage up-to-date postings (at least once a month)
- Prepare and distribute quarterly per capita statements to sessions.

- 6. Investment Policy (To be revised by Investment sub-committee)

 - B. Sample COM motions

These are the policies we need:

- 1. Officer/Volunteer policy Elections, resignations, expectations
- 2. Communication Policy Who authorizes communication to the Presbytery?
- 3. Anti-racism policy

I believe we should try to form a manual that helps to clarify the various roles throughout the Presbytery and that will clarify procedures.

Matthew 25

As of November 25, seven congregations in the Presbytery have signed up as Matthew 25 churches: Roxbury, KCB, Burlington, Clinton, Natick, COTC, and Sudbury. We also have a dedicated tab on the website, https://www.presbyteryofboston.org/Matthew-25, which is where different resources and calls to action will be posted. At our December Assembly meeting, we will be marking one year since joining the Matthew 25 movement. My hope is that more churches will feel called to grab ahold of this vision and engage the three foci of building vital congregations, dismantling structural racism, and eradicating systemic poverty.

In November, we engaged with the Rev. Denise Anderson across two Saturdays around the theme of building stamina for anti-racism work. Those recordings can be found on our website, and other resources for building stamina will be added soon.

Following are a Summary of Council's Actions. You can view the full council minutes <u>on the</u> Presbytery website.

On October 29, 2020, council took the following actions:

- 1. The council **voted** to disburse \$1,500 from the shared mission budget item to the Presbyterian Mission Agency in gratitude for this Building Stamina for Anti-Racism work seminar.
- 2. The council **voted** to elect Katie Cole to serve as moderator pro tem of the next Presbytery meeting. This power was delegated to the council by Presbytery at its last meeting.

On November 19, 2020 council took the following actions:

- 1. The council voted to **recommend** budget scenario 1 to the Presbytery. The recommended budget is in this packet.
- 2. The council **voted to approve** a job description for a communications coordinator and to recommend that Presbytery approve a \$12,000 per year line item to the 2021 budget. This job description is a one-year contract.
- 3. On November 5, over email, the council **voted to approve** the grant proposal to create a Christian Education Youth Coordinator Position at Hartford St. Presbyterian Church. The funds, \$19,900, will come from the Linn Redevelopment Fund of the Presbytery of Boston. Hartford Street will provide a report annually on progress of the project.
- 4. Council voted to recommend the following task force of the Presbytery with the following charge:

Charge for Task Force

The Administrative Manual Task Force will consist of 3-5 members of the Presbytery of Boston. Members may be minister members, ruling elders, or members of Presbytery of Boston Congregations. The Stated Clerk will provide staff support to this task force. The task force will be appointed by the Presbytery of Boston Council.

- A. Gather and review existing policies of the Presbytery of Boston and determine which policies need revision.
- B. Determine a process for revision of existing policies.

- C. Determine if new policies that should be formed.
- D. Write new policies or recommend a process for forming new policies to be recommended to the Presbytery for Approval.
- E. Compile the policies into an Administrative Manual to be recommended to the Presbytery at the November Presbytery Meeting.
- 5. The council **voted** to recommend that the March Presbytery meeting be held virtually.
- 6. The council **voted** to recommend the calendar below to the Presbytery.
