

## Presbytery of Boston Council Minutes

**Purpose, Date and Location of Meeting:** This Stated Meeting convened on April 11, 2019 online via Adobe Connect.

**Opening:** Veronica was delayed, so TJ asked Eric to act as moderator until Veronica's arrival. It being determined that a quorum was present, Eric opened the meeting with prayer at 7:06pm.

Adoption of Agenda and Approval of Minutes: Eric asked for approval of the agenda. It was moved and seconded to approve the agenda. *Approved*. Eric asked for approval of the minutes from the January meeting. It was moved and seconded to approve the minutes from the January meeting. *Approved*. Veronica came online shortly thereafter, and assumed her duties as moderator.

## **Report of Officers:**

**Treasurer-** Andy gave his report. He said we are behind by \$15,000. He also said that since January 2015, the presbytery has expended all of its working cash. He said it was his opinion that this situation is systemic. TJ suggested pulling together a task force to work on the next budget, and to look into ways to keep the presbytery solvent. Andy liked the idea, and volunteered to put together a job description for the task force. Cindy suggested that one of the members must be from Trustees. After further discussion, **it was moved and seconded to direct the Treasurer to draft a job description for a budget task force, request that the Trustees appoint two members to this task force and authorize the Presbytery Moderator to appoint three members from council to serve on this group.** *Approved*. After further discussion, **it was moved and seconded to accept the Treasurer's Report.** *Approved*.

**Stated Clerk-** TJ gave a brief report: The gist of it concerned how things are going with Presbytery Communications Coordinator Ben Chika, and about follow-up after the Vital Congregations gathering in May. There were no actions for Council.

**Resource Presbyter-** Cindy gave a digest of her written report. She said that registrations for Vital Congregations have been slow. She expressed concern with this. She suggested the possibility of having Rev. Dr. Diane Moffett, Executive Director of the Presbyterian Mission Agency attend the end-of-year Presbytery meeting. **It was moved and seconded to invite Rev. Dr. Diane Moffett, Executive Director of the Presbyterian Mission Agency to the December Presbytery Meeting.** *Approved.* In concluding her report, Cindy spoke of her desire to grow the presbytery citing the Shekinah congregations as a "model." After a short discussion, it was decided that this was a conversation worth continuing. There were no actions for Council.

**YAV Program-** Sarah Goodloe, the representative from the Boston YAV Food Justice program gave a presentation of their activities moving forward. She then asked for the council's endorsement of a Pentecost Campaign- 1\$ per congregation per month continuing through 2020- to cover the living costs of the YAVs. After a time of Q&A and discussion centering on ways the YAVs could "network" with the churches of the presbytery, **it was moved and seconded to endorse the YAV Pentecost Fundraising Campaign.** *Approved.* 

## **Committees of Presbytery:**

**Committee On Ministry (COM)** – Eric gave a report. He spoke of a health care initiative being initiated by the Hartford Street Church and for which they were seeking funding from the PCUSA. He asked that the council endorse Hartford Street Presbyterian for use of restricted funds of the PCUSA on a health care project. *Approved*. He then mentioned that in its 2019 budget, the presbytery is remiss in not meeting its own guidelines for 3% pay increases for presbytery staff. Andy, Cindy and TJ recused themselves, at which time, Eric suggested that a motion be made to retroactively give presbytery staff a 3% raise. It was moved and seconded to recommend a 3% pay increase retroactive to January 2019 for presbytery staff. *Approved.* Eric said he'd write the rationale for the pay increases for presentation at the next presbytery meeting.

**Committee for Preparation for Ministry (CPM)** – Kristin gave her report, speaking of the activities at their most recent meeting and their interactions with those under their care. There were no actions for Council.
